

CONSTANTA CALLING INSTRUCTIONS

Please instruct Master:

- To give ETA by fax/mail 48/24/12 hours before arrival at Constanta anchorage
- To contact Constanta control (**VHF CH 67**) 12 NM before arrival and declare/verify anchoring position with Traffic control
- To be stand-by on VHF CH 10, 2-3 hours before arrival and contact Island Petroleum SRL or our bunkering vessel, M/T 'Amalthia' should Vessel is calling for bunkers only.
- In order to be allowed to enter in Romanian waters, to send to Island Petroleum SRL by email/fax security the templates for to be inserted in the Maritime Single Window - related information using the below link - at least 24 hours prior to arrival to Constanta port
- Pilots** are to be contacted on **VHF CH 14**. The pilot boat will wait 0.5 nm east of the North Jetty except during adverse weather conditions where the pilot will embark between the breakwaters.
- Free pratique** will take place on arrival and is made 24 hrs a day. The Port Authorities will board vessel together with the agent to perform free pratique procedure.

Important: Failure to submit the required forms and information may result in denial of Vessel-entry into Port, as indicated in IMO, MSC/Circ 1130

Master to have ready on arrival :

- 8 Crew List
- 3 Ship's Store Declaration
- 3 Crew Effect Declaration
- 3 Crew Money Declarations
- 5 Ship's Particulars
- 5 List of last ten (10) ports-of-call
- 4 Cargo Manifest from last port (If you have cargo in transit)
- 3 NIL List
- ISSC (Int'l Ship Security Certificate)
- Maritime Health Declaration + One Copy Of Ship's Medical Certificate + One Copy Of Nonderating Certificate (Sanitation) + 2 Crew List (For Quarantine Officer)

If vessel arriving first time in Constanta or have any changes to vessel's certificates, in addition, please provide our office 24 hrs prior to arrival and have ready on arrival the following:

- Ship particulars
- One copy of Tonnage Certificate
- One copy of Certificate of Registry

Please note that all above documents have to be stamped and signed accordingly.
